### Ministry of Justice Criminal Record Check - PLEASE READ CAREFULLY

The Government of British Columbia requires all students who have access to children or vulnerable adults during the course of their studies to pass the Ministry of Justice Criminal Record Check Schedule Type **B** application for working with '*children and vulnerable adults*'.

Results which identify relevant criminal convictions may disqualify an applicant from admission into a program. The cost of this search is the responsibility of the student. For further information, please see:

#### Consent to a Criminal Record Check

- Schedule Type is B
- Select: Children and Vulnerable Adults
- Complete Part 1
- Complete Part 2 Section A

  - ID Number: 107985
  - Organization Type: College
- Complete Part 3 – sign and date

#### Submit your form
